



Fueling the Future: SheBoot Launches 2025 Cohort of Women-Led Ventures

Ottawa, Ontario — July 8, 2025 — SheBoot, the national non-profit that prepares women founders to pitch their business and secure investment, is proud to announce the 15 women-led Canadian tech startups selected to join its 2025 cohort. These entrepreneurs are from all across Canada and are driving innovation across a diverse range of sectors including medtech, software, consumer, life sciences, and more.

Since SheBoot's inception in 2020:

- 65 founders have graduated from the SheBoot program
- 52 women angel investors, both new and experienced, have joined the SheBoot Investment Group
- The SheBoot Investment Group has invested more than \$1.3 million in SheBoot graduate companies
- SheBoot graduates have gone on to raise over \$45 million in additional investment

- Katheryn Vurinaris, Founder and CEO of [Sleaks](#), which creates reusable bladder leak underwear for men and women that empowers independence because it is discreet and reliable, breaks stigma, builds confidence, and also protects the planet.
- Paola Marcato, Co-President of [Theranib](#), a biotechnology company that develops first-in-class precision medicine to combat cancer metastasis and chemoresistance.
- Mariia Zhuldybina, Co-Founder and CEO of [TRAQC](#), which is transforming printed electronics by replacing costly, slow quality checks with real-time, AI-powered defect detection.
- Ella Farlinger, Co-Founder and COO of [trusti](#), which aims to revolutionize the care and education surrounding sexually transmitted infections (STIs) with at-home rapid STI testing, follow-up care, and digital learning tools.
- Vanessa Lo, Co-Founder and CEO of [VanTech Med](#), an intelligent companion doll designed to comfort and engage older adults while tracking mood and supporting caregivers through real-time insights.
- Samira Soltani, Co-Founder and COO of [Wireless PnC](#), which develops compact, flush-mounted wireless charging pads for e-bikes and e-scooters that are compatible with all sizes and brands of batteries and retrofit-friendly, enabling safe, and convenient energy transfer in public spaces.

This fall, these visionary founders will participate in an intensive six-week bootcamp designed to accelerate the growth and success of their technology or technology-enabled startups. The program includes investment-readiness training, coaching, advisory services, and more. It culminates in a pitch competition where the top three founders will secure equity investment from the SheBoot Investment Group. The prize pool consists of a total \$300,000 investment prize pool, with awards of \$150,000, \$100,000, and \$50,000 for the top three founders.

SheBoot

SheBoot received applications from more than 160 startups across Canada. After a rigorous evaluation, 15 outstanding founders were selected. The 2025 cohort includes entrepreneurs from four provinces: British Columbia, Ontario, Quebec, and Nova Scotia. 60% of this year's founders self-identify as BIPOC, and their ventures span a broad range of sectors including SaaS, medhealth, cleantech, consumer products, and life sciences.

According to the National Angel Capital Organization's most recent report, women-owned businesses receive just 4% of venture capital funding in Canada. SheBoot is on a mission to change that.

SheBoot is designed by women investors and entrepreneurs for diverse women founders. It supports early-stage women-led companies where the funding gap is most pronounced, and access to capital and investment readiness are critical. SheBoot is building a robust community of women founders and women investors driving economic and social impact from Main Street to Bay Street to Sand Hill Road.

SheBoot was founded in partnership with [Invest Ottawa](#) and [Capital Angel Network](#). SheBoot is a national non-profit that prepares women founders to pitch their business and secure investment. Founded by Jennifer Francis, Julia Elvidge, and Sonya Shorey with the Capital Angel Network and Invest Ottawa in 2020, SheBoot was created to help close the funding gap for women entrepreneurs by increasing the number of women founders who secure investment and the number of women making investments. It provides intensive investment-readiness training and culminates in a pitch competition for a minimum of \$300,000 in equity-based funding from women angels.
